Gift Aid Notes

1. If your declaration covers donations you may make in the future:

a) Please let Letchworth Settlement know if you change your name or address while the declaration is still in force.

b) Cancellation of declaration: You can do this at any time by notifying Letchworth Settlement, it will then not be applicable to donations you make on or after the date of cancellation.

2. You **must** pay an amount of Income Tax and/or Capital Gains Tax at least equal to the tax Letchworth Settlement reclaims on your donations in the tax year (currently 25p for each £1 you donate).

3. If your circumstances change in the future and you no longer pay tax on your income and/or capital gains equal to the tax that Letchworth Settlement reclaims, you can cancel your declaration.

4. If you pay tax at the higher rate you can claim further tax relief in your self-assessment tax return.

5. If you are unsure whether your donations qualify for Gift Aid tax relief, consult Letchworth Settlement. Alternatively, please contact your local tax office for advice.
